1.1 Introduction

The Naivasha Water and Sanitation Company would like to invite interested candidates who must qualify by meeting the set criteria as provided by the procuring entity to perform the contract delegated operator of a water service.

1.2 Registration Objective

The main objective is to recruit a group/an individual that will undertake the operations of the constructed water point under terms and agreement to be determined by the procuring entity (NAIVAWASCO).

1.3 Invitation of Registration

Registered business enterprises in respective or related operations are invited to submit their complete APPLICATION documents to NAIVAWASCO, so as to be prequalified for application of water point operators. The prospective enterprises are required to supply mandatory information for registration.

2.0 QUALIFICATION

2.1 Eligible applicants must be persons/businesses/firms registered and operating in Kamere Naivasha Area.

2.2 It is understood and agreed that the application data on prospective bidders is to be used by NAIWAWASCO in determining, according to its sole judgment and discretion, the qualifications of prospective bidders to perform in respect to the requirement as described.

2.3 Applicants should meet the criteria as follows: -

- i. Be a registered business entity with relevant government departments and been operation for at least the past one year preferably in water supply or related activities (for a business or a firm).
- ii. Be active in the area Kamere Beach where the water point is located.
- iii. Minimum O-level education for operators.
- iv. Demonstrate capability of raising water deposit of Ksh. 5,000 upon selection.
- v. Demonstrate a minimum annual turnover of KShs 50,000 in the current business/enterprise.
- vi. Understanding of the institutional arrangements of the Kenyan Water Sector is desirable.

2.4 Prospective bidder will not be considered qualified unless in the judgment of organization they possess capability, experience, and qualified personnel available and financial capability sufficient to satisfactorily execute the contract for goods / services.
